



Buyer/Bidder Terms and Conditions

1. The highest bidder acknowledged by the auctioneer shall be the winning buyer. In the event of any dispute between bidders, the auctioneer shall have the final decision to determine the successful bidder or to re-sell the article in dispute. If any dispute arises after the auction is completed, Dovetail Auction Gallery sales records will be the deciding factor.
2. Please inspect items carefully before deciding to bid. All items are sold as is, where is.
3. Dovetail Auction Gallery and its' consignor(s) assume no risk, liability or responsibility for the authenticity of any property sold.
4. Dovetail Auction Gallery reserves the right to withdraw any property at any time before actual auction.
5. Dovetail Auction Gallery accepts absentee and phone bids at all of their sales. This means that if a bidder is unable to attend the sale in person, Dovetail Auction Gallery will execute bids without charge and without responsibility for errors as subject to the terms and conditions of the auction. Absentee and telephone bids are accepted at the bidder's risk.
6. If the auctioneer determines that any opening bid is not a reasonable price considering the value of the item offered, she may reject the bid and withdraw the item from sale. The auctioneer reserves the right to reject any unreasonable advance.
7. On the fall of the auctioneer's hammer, ownership and/or title to the lot for sale will pass to the highest bidder who will then assume full risk and responsibility for it and will pay the full purchase price including the buyer's premium and applicable sales tax.
8. All property shall be removed from Dovetail Auction Gallery by the

successful buyer at his or her own expense no later than 7 days after the auction. If an item is left on the premises after the 7 day period it will be re-sold at the following auction to pay for its storage costs. The buyer's money will not be refunded for the unclaimed item.

9. All purchasers will be required to pay the Rhode Island State Sales Tax at the rate of 7% unless exempted by the state. **Tax Exempt Buyers: MUST PROVIDE A COPY OF CURRENT (2014) SALES TAX (RESALE) CERTIFICATE OF EXEMPTION** or Applicable Sales Tax will be charged - NO EXCEPTIONS!

10. All items are sold AS IS, WHERE IS. No warranty of any kind is expressed or implied. No Exceptions. Dovetail Auction Gallery nor any of its' consignor(s) makes any warranties or representations of any kind with respect to the property and no statement made at the auction or printed anywhere shall be deemed such a warranty or an assumption of liability.

11. Bidders/Buyers hereby agree to hold harmless and indemnify DOVETAIL AUCTION GALLERY, Cranston RI 02910, its Owners and Agents from any claims, suits, or causes of action which may arise from and out of the removal by the undersigned of any property acquired by the bidder at any of our auctions.

12. A 15% Buyers Premium (fee) will apply to all purchases made at the auction to be paid by the buyer as part of the purchase price.

13. A \$50.00 fee will be charged on returned checks – NO EXCEPTIONS!

14. Terms and Conditions, which are announced at the auction, take precedence over the information printed here.

15. The act of bidding on an item constitutes your acceptance of these terms and conditions.
